#### 8. Summary

In Burkina Faso's Est Region, 80 per cent of the population live essentially from agriculture. Each year sees pockets of famine, so that each member of society does his or her best to avert this threat. Against this background, men and women cassava producers and processors in Goulmou are increasingly focusing on lean-period crops, especially cassava, which can be processed into such products as gari, attiéké and tapioca. Cassava is grown for its leaves and especially for its starch-rich tuberous roots, and it can be consumed in the form of green cassava or flour. In some regions of Burkina Faso, the inhabitants tended to give the crop little importance, although it is very effective in countering hunger and poverty. However, large quantities of cassava-based products are imported into the country, especially the Est Region, for lack of appropriate technology, equipment and people trained in their production. It has been clearly recognized that cassava cultivation has a considerable economic impact. UPTMG is therefore seeking ways of developing and promoting this crop, and thus undertook an awareness campaign for 2,163 men and women cassava producers between 2005 and 2007, dividing them into 82 local cassava production groups. Today the union wants to popularize and develop cassava cultivation in order to guarantee food security in the Est Region.

#### 9. What issues does the innovation address?

- Rural and female poverty
- Obtaining the means to meet the health, food and education needs of all the producers affected by the project

#### 10. Key success factors for replication

- Raising of the necessary financial and material resources to implement the project
- Successful training, which must boost producers' technical capacities
- Administrative decentralization and a policy of good governance, thanks to the involvement of local authorities, including village development councils
- Suitable environmental and climatic conditions

#### 11. Main results

Increase in producers' income, increase in producers' technical capacities, improvement in health, improvement in children's school attendance

Goulmou village groups

#### 13. Difficulties encountered

Lack of agricultural inputs (cassava cuttings, insecticide, wire netting, carts, ploughs, draught animals, training, literacy training etc.)


