8. Summary:

PRONAF facilitated the establishment of a regional platform involving public and private cowpea stakeholders, farmers' organizations, NARES, IITA, NGOs and IFAD funded loan and grant-financed programs, and other development partners interested in the cowpea value chain. This platform was intended to coordinate interventions and to promote sustainable cowpea production systems in the target countries through information exchange and development of linkages between research, public and private sector and NGO actors. Key activities include on-going network development and the organization of workshops.

9. What issue does the innovation address?

- Low rate of innovation adoption;
- Strengthened vertical and horizontal coordination of market actors;
- Increasing involvement of policy makers.

10. Key success factors for replication:

- Each innovation or practice responds to farmers' concerns in a specific way (relevance);

- Strengthen demand-driven capacity building;

- Exchange information at all stakeholder levels, including resource-poor farmers and their organizations, IFAD projects, the private sector and NGOs;

- Enhancing capacities and sustainable access to cowpea-based market opportunities and information will result in sustainable income generation, improved food security, and poverty reduction
